### 4. FIRST AID MEASURES

## 7. HANDLING AND STORAGE

**Handling:** Good ventilation of the workplace required. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable.
